# MANAGERIAL CHALLENGES OF FAMILY BUNSINESSES

October 15-16, 2015 – Marrakesh- Morocco

The Research Group on Family Businesses and Strategies of Organizations (**GREFSO**) was created in 2007 in Cadi Ayyad University (Marrakesh-Morocco). It is a pioneer research structure at the national level regarding its interest on the topic of family firms in Morocco.

The nine years of experience of the **GREFSO** were full of accomplishments through organizing many events (conferences, doctoral consortiums,...), supervising or cosupervising theses and producing many articles, proceedings and a book.

This year, the **GREFSO** decided to go a step further by organizing, in collaboration with the **IRGO** (University of Bordeaux), the doctoral cycle of the **ISCAE** and with the participation of the **IEF** (Institut de l'Entreprise Familiale - Family Enterprise Institute – Belgium), an international conference called **FREF** (Forum de la Recherche en Entreprises Familiales). This conference is meant to be an annual meeting for researchers, Ph.D students, managers, family firm members and any other stakeholder that would like to discuss, share and contribute to family business research.















The main topic of this 1st Conference on Family Business Research is about: **Managerial** challenges of family businesses.

Potential contributions to FREF 2015 include, but are not limited to, the following points:

# **GOVERNANCE**

- What are the obstacles and difficulties that family firms face when it comes to their governance?
- Are the family charter and/or the family council efficient tools?
- How can it be possible to manage the cohabitation of many generations without compromising the governance system of the family firm?

## **SUCCESSION**

- What are the impediments to the success of family business transmission to the next generation?
- Does the gender of the (futur) successor imply a differentiated management of the succession process?
- How can the succession be successful?
- How does the post-succession needs to be managed?

# **EMOTIONAL DYNAMICS**

- To what extend do rivalries and conflicts threaten the longevity of family firms?
- What is the role of emotions in family firms' management?
- Is the emotional involvement of family members a strength or a disadvantage for the success and the longevity of family firms?















# **INTANGIBLE ASSETS**

- What is the importance and role of intangible assets in family firms?
- Is organizational learning and knowledge transfer any specific in family firms?
- To what extend is the social capital of family firms a source of competitive advantage?
